ORDINANCE NO. 45

**AN ORDINANCE ESTABLISHING RATES FOR
THE COLLECTION OF SOLID WASTE
BY MARIN SANITARY SERVICE
IN THE UNINCORPORATED AREAS OF KENTFIELD, GREENBRAE,
DEL MESA HEIGHTS, AND KENT WOODLANDS**

WHEREAS, Sanitary District No. 1 of Marin County ("District") and Marin Sanitary Service ("Company") entered into an Agreement dated May 16, 1995, for the collection of Solid Waste within the District in the unincorporated areas of Kentfield, Greenbrae, Del Mesa Heights, and Kent Woodlands; and

WHEREAS, Sections 4 and 5 of said Agreement provide that the rate schedule for Solid Waste shall be periodically established by ordinance of the District after a duly noticed public hearing.

THE BOARD OF DIRECTORS OF SANITARY DISTRICT NO. 1 OF MARIN COUNTY DOES ORDAIN AS FOLLOWS:

SECTION 1: The schedule of rates to be charged for Solid Waste collection in the unincorporated areas of Kentfield, Greenbrae, Del Mesa Heights, and Kent Woodlands shall be as shown on Exhibit "A" attached hereto and made a part of this Ordinance.

SECTION 2: The rate schedule shall be in effect from July 1, 1996.

SECTION 3: This Ordinance shall take effect and be in full force and effect on July 1, 1996, after publication in the Marin Independent Journal, a newspaper of general circulation published in Sanitary District No. 1 of Marin County.



**MULTI-FAMILY RESIDENTIAL SERVICE IS ONE CONTAINER
PER LIVING UNIT - MINIMUM**

The above rates shall apply to cans located not more than five feet (5') from the street where a standard garbage truck can travel. For any can located more than five feet (5') from, but less than fifty feet (50'), add \$1.75 per can per month. For any can located more than fifty feet (50'), add \$4.15 per can per month for each additional fifty feet (50') or portion thereof.

If special equipment is required to get to the location of the can, the charge for special equipment shall be the same as the extra distance charge; however, the customer shall not pay for both the special equipment and the extra distance. For Multi-Family Residential and Commercial only, the above rates will be doubled for two collections per week, tripled for three collections, etc. Single Family Residential can not receive multiple collections per week.
