Lateral Replacement Loan Program

Updated November 19, 2019

Thank you for helping us protect and preserve our local environment by replacing your privately-owned sewer lateral. By allowing the District to assist you with this project, together we will reduce contamination in our community and waterways, as well as reducing treatment costs for the entire Ross Valley. Hopefully, through District public outreach efforts, you have learned that nearly 50% of all sewer spills are caused by leaking privately owned lateral pipes. Private laterals are the responsibility of the property owner, from the building to and including the connection at the District main line. The Lateral Replacement Loan Program was designed to encourage property owners like you to repair or replace your pipe and help to protect the beautiful Ross Valley.

The District offers low interest **loans up to \$25,000** to replace your private sewer lateral. Repayment of loans will be over a period not to exceed ten (10) years at an **annual interest rate of 3.6%**. Payments will be collected through the semi-annual property tax bills as a special assessment.

NOTE: Common (shared) laterals are not eligible for loans because they do not conform with the District's specifications or the Uniform Plumbing Code Section 721.1, which require laterals from each property to connect directly to the public sewer main.

The following requirements are necessary to apply the District's loan program:

- 1. Signed Lateral Replacement Loan application (available at rvsd.org),
- 2. A DVD of the video inspection performed by one of the District's pre-qualified contractors **DVD must be within a year from date of application.**
- 3. Completed Sewer Lateral Inspection Report Form (required if RVSD representative is not present for the CCTV inspection), and
- 4. Three (3) lateral replacement bids from any of the District's pre-qualified contractors **Bids must be within 90 days from date of application.**

The District will review your application and notify you about the status of your loan request, usually within 10 working days. The District will provide loan funding based on the lowest qualified bid. However, the property owner can choose whichever contractor they'd like to work with. If the application is approved, the Property Owner will be required to sign a Contractual Assessment Agreement, which will be recorded against the property.

A flow chart of these steps, the Inspection Report Form, the loan application and a list of pre-qualified contractors is included on the following pages. Contractors who are interested in being added to the list should contact the District. Many contractors already understand the program and can assist you in the applying. We are more than happy to assist you over the phone, in our office, or in the field as well. Please contact us with any questions you may have.

Private Sewer Lateral Inspection Report Form

This form must be completed by the Property Owner and submitted with the application for the Lateral Replacement Grant Program or Lateral Replacement Loan Program. The Property Owner is responsible for ensuring that the contractor conducting the video inspection meet the following requirements:

- Contractor shall hold either: An A, B, C-36 or C-42 license with the California Contractors State License Board, or National Association of Sewer Service Companies Pipeline Assessment and Certification Program (NASSCO PACP) certification,
- 2. Video shall visually verify the property address of the lateral being inspected,
- 3. An audio recording describing all issues with the lateral being inspected along with a footage counter to show length of pipe MUST be included as part of the inspection report,
- 4. Lateral must be cleared of significant debris and/or obstructions to provide a clear view,
- 5. All reasonable efforts must be made to fully inspect the <u>entire lateral</u>, including cleaning and removal of obstructions,
- 6. Any lateral tie in connections need to be inspected and their source identified.

Applications that do not include this form will be rejected. DVDs submitted that do not meet the above requirements will be rejected. Incomplete video inspections, where reasonable efforts to clear the lateral were not made, will be rejected.
